Laboratory and Environmental Professionals,

The purpose of this letter is to advise you that the Department of Environmental Protection's Bureau of Solid and Hazardous Waste (BSHW) is actively reviewing our electronic needs and is upgrading the management of databases to better serve the technology demands of the regulated community and the public.

With that in mind, the BSHW in conjunction with Laboratory Data Consultants, Inc. (LDC) has developed Automated Data Processing Tool (ADaPT) software for the automated evaluation of groundwater (GW) data. Beta testing is currently in progress for ADaPT with anticipated production release in the near future. ADaPT runs under Microsoft Access and is a tool that laboratories, consultants, solid and hazardous waste facility permittees and Department staff can all use to evaluate groundwater data. Initially this program is being developed for the BSHW programs; however, it is also used by the Department's Bureau of Laboratories and may be expanded to other programs in the future.

We believe ADaPT is a great tool that can save considerable time in the review and reporting of data. An added benefit is that the BSHW can then upload this data to our Water Assurance and Compliance System (WACS) database that is available to the general public. Uploading solid and hazardous waste groundwater data to WACS will also help the Department evaluate impacts to groundwater from regulated facilities and provide a database of water quality information that can be useful in rulemaking.

ADaPT has been developed to comply with the Department's quality assurance requirements and provides many functions. Specifically, ADaPT performs an error check for correctness, and completeness of the data, checks blank contamination rules and checks accuracy and precision criteria for each method and sample matrix. In addition, ADaPT performs a data review that measures integrity of sample results against associated laboratory quality control, holding times, and method detection limits. ADaPT also checks the results for compliance against numerous user selectable criteria and standards. ADaPT has a built in function that will import the latest testsite inventory from the Department's WACS database via public file transfer protocol (FTP). ADaPT then checks the submitted testsite data against the most recent WACS testsite inventory prior to data export. Currently, several laboratories and clients authorized for Department related work are already providing data in ADaPT format and are reporting substantial savings.

With the implementation of ADaPT there will no longer be a requirement to manually submit laboratory data reports since the data is included in the ADaPT laboratory electronic data deliverable (EDD) file in a universally consistent format. It will also no longer be necessary to submit data on the groundwater monitoring report form, DEP Form 62-522.900(3), with associated STORET codes.
