



Rx Tracker allows Conditionally Exempt Small Quantity Generators (CESQG) to dispose of unwanted or expired pharmaceuticals. This new mailback service features:

USING THE SYSTEM

- When the container is full, replace the lid. Secure lid to bucket. Use enough force to ensure lid is fully engaged on bucket.
- Place the bucket into the prepaid return box.
- Close the box, making sure the flaps labeled "Must Be Visible for Return Shipping" are exposed.
- Seal the box using the provided tape. Be sure to cover all top seams.
- Follow the instructions below to ship the bucket to Waste Management.
- Visit medwaste.wm.com to verify receipt and destruction of your package.
- * **Do not put the following EXCLUDED items in the container:** controlled substances, mercury-containing devices, radioactive materials, sharps such as hypodermic needs and lancets, pharmaceuticals not in final form for use as a drug or medicine, organic peroxides, regulated medical waste or biohazardous waste, bulk aerosols (no more than 3 inhalers)

ARRANGING FOR TRANSPORTATION

- The Rx Tracker can be shipped only through UPS Ground.
- If you have UPS daily pick-up service:** Hand the package to your regular UPS driver. **If you do NOT have UPS daily pick-up service:**
- Hand the package to any UPS driver you see; or
- Drop off the package at any UPS retail outlet. Visit ups.com to find the drop-off point nearest your zip code; or

WARNINGS

Package weight should not exceed 55 pounds.

This product is not authorized for use by individual consumers or community collection programs.

(1) It is a violation of law to use Rx Tracker for disposal of controlled substances or precursors as defined under the Controlled Substances Act or corresponding state laws. Customers are responsible for ensuring that no controlled substances or precursors are shipped in the Rx Tracker container.

(2) Rx Tracker is authorized for use only by Conditionally Exempt Small Quantity Generators (CESQGs), as defined under federal hazardous waste regulations, and their equivalent under state law. These rules require, among other things, that CESQGs generate no more than 100 kg of total hazardous wastes, and no more than one kg of total acute hazardous wastes, in a calendar month. All customers must have a Certification of CESQG status on file with WM Healthcare Solutions, Inc. (WMHS) and must update WMHS in the event their status changes.

(3) Regulated medical waste (RMW), also known as "biohazardous waste" or "infectious medical waste," is prohibited from disposal through Rx Tracker. Such wastes include any wastes that may be contaminated by blood, bodily fluids or other potentially infectious materials, thus posing a significant risk of transmitting infection.
