*Paint Product Stewardship Meeting: The Product Stewardship Institute (PSI) is facilitating the sixth meeting of a national dialogue aimed at reducing the generation of leftover paint, while increasing reuse and recycling opportunities. With the support of dialogue participants from over 50 companies, industry associations, and government agencies like FDEP, a Memorandum of Understanding (MOU) was developed to work on projects that will become the basis for developing a nationally coordinated paint management system. Alachua, Broward, Highlands, and Leon counties endorsed the MOU. County HHW programs managers are encouraged to attend and observe this dialogue in process.
