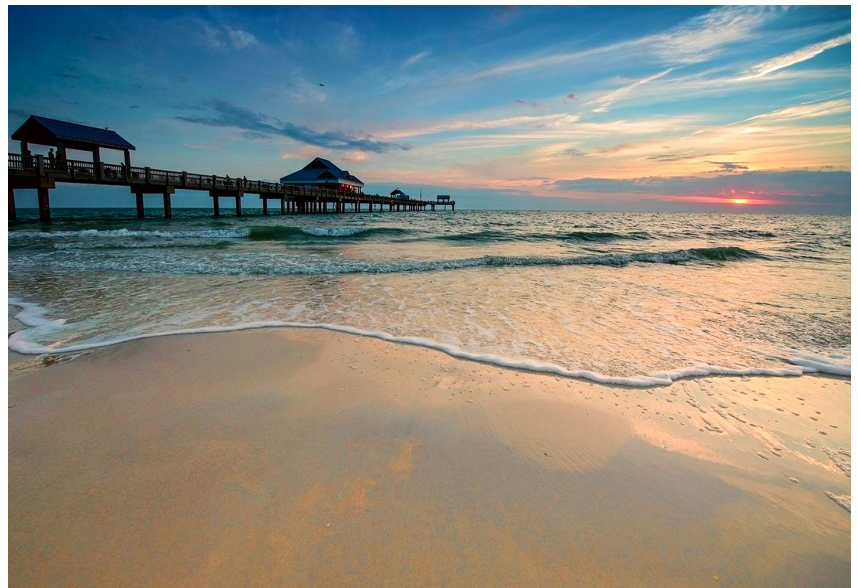

## Call for Presenters

- **Panel session on one complete topic**  
Prepare a full panel session (60 to 90 minutes) devoted to an entire topic, complete with pre-selected presenters (may include yourself).
- **Problem solving dialogue**  
Submit a proposal for a 60 to 90 minute facilitated discussion session on a relevant topic.
- **Work session on a project in the development stage**  
Audience participates in planning the project and preparing for the implementation.
