This position performs responsible administrative and supervisory work overseeing and integrating the operational programs of the Solid Waste Management Division to promote excellent customer service and ensure responsible fiscal and environmental stewardship. The operational programs include the Gum Road Transfer Station, the Apalachee Solid Waste Management Facility, Hazardous Waste Program, and the Rural Waste Service Centers.

Manage operations, identify priorities, and use problem solving skills to provide solutions throughout the Solid Waste Division. Evaluate policies, provide technical assistance, and refine procedures.

Coordinate and address needs and concerns of Departments, vendors, and citizens in regards to general needs and special projects; assist in promoting programs, identify cost savings, leveraging partnerships, and investing in knowledge and skill sets of staff.

Ensure operations remain in regulatory compliance with local, state, and federal environmental and operational requirements, through required testing, reporting, and certification.

Serve as contract administrator for services such as waste collection, recycling, hauling and disposal; write solicitations, abide by terms, and ensure vendor compliance.
